

IMPORTANT - Settlement Timescales for Solicitors & Builders

Deadlines apply when processing funding claims and all necessary information is required in advance to ensure we have funds in place for your intended completion date. Within this period, we will contact Harper MacLeod solicitors who will issue all legal documentation for parties (including the buyer, lenders and Scottish Government) to sign and return.

Existing Properties

- ✓ Solicitors Confirmation Letter
- ✓ Home Report – this should have been provided with the initial Application

New Build Properties

We will contact Harper Macleod on receipt of the following documentation:

- ✓ Solicitors Confirmation Letter
- ✓ UK Finance Disclosure Form (complete with development details and full postal address)
- ✓ Mortgage Offer detailing loan amount, fees, expiry date, purchase price
- ✓ Valuation Report from the lender (unless stated on the mortgage offer)

If we do not receive these documents settlement may be delayed.
